Resources for Your Family & Community to Rebuild After Hurricane Helene

The effects of Hurricane Helene have rocked South Carolina. Community members have lost their lives, powerlines and trees remain down, and roadways are impassible. Flooding and river cresting continue to pose a concern, while hundreds of thousands of South Carolina residents will continue to be impacted for days and, unfortunately, even weeks to come.

Despite the devastation, neighbors, communities, and leaders have worked together. Dealing with their own losses, the Department of Social Services' staff of more than 4,500 professionals have worked tirelessly staffing emergency shelters, clearing trees and limbs from the roadway, and answering calls to move our state toward recovery.

SNAP Replacement Benefits

DSS has requested a waiver from the U.S. Department of Agriculture (USDA) that if approved will allow DSS to automatically issue federally funded food replacement benefits to current SNAP recipients residing in counties where 50% or more of the total population in that county experienced a power outage lasting more than four (4) hours per federal guidelines.

If you are without food and need immediate assistance, food is available at your local food bank. Emergency shelters and feeding sites are also operating in some areas.

Updates on Infrastructure

Over 500,000 power outages are continuing to be repaired. Thousands of line workers are working

around the clock to repair these lines.

The South Carolina Department of Transportation continues to focus on cleanup efforts throughout the state. Crews are working around the clock to clear roadways and get South Carolina back to normal.

Despite anxiety about the state's dams and waterways, the South Carolina Department of Environmental Services (SCDES) Dam Safety Team has assessed the condition of 149 stateregulated dams and there are no significant issues reported or observed.

Individuals in Aiken, Anderson, Bamberg, Barnwell, Cherokee, Greenville, Greenwood, Laurens, Lexington, Newberry, Oconee, Pickens, Saluda, and Spartanburg Counties can apply with FEMA in the following ways:

Even if your county is not currently on the list of approved counties to receive disaster assistance, it may still be added by FEMA later if it has incurred widespread destruction. If you have sustained losses, you may apply for disaster assistance before your county is added to the list at this website: www.DisasterAssistance.gov.

If you need free damage clean-up assistance call Crisis Cleanup at 844-965-1386. Volunteers may be able to assist with:

- Mucking out
- · Cleaning up trees
- Tarping roofs
- · Clearing debris

If power and WIFI continue to be issues for you in your home or temporary shelters, please visit your local library. South Carolina's libraries offer computer access, WIFI, printing capabilities, access to resources, entertainment for your children, and much more for free.
